KLEZMER CONCERT SUNDAY, NOVEMBER 21 3PM, DANBY TOWN HALL

The Cornell University Klezmer Ensemble will give a free concert at the Danby Town Hall as part of the Danby Community Council's concert series. The ensemble is directed by Joel Rubin, who also plays clarinet, and includes musicians Lauren Cohen (piano and voice), Ilana Goldowitz (cello), Rima Grunes (violin), Steve Hertzberg (basoon), Karin Herzog (flute and piano), and Bob Wyttenbach (cello).

Klezmer was originally the ritual and celebratory music of the Yiddish-speaking Jews of Eastern Europe, where it developed over the course of many centuries. Brought to the US with the immigration wave during the period 1881-1924, a modern klezmer tradition developed in the urban centers. Since the 1970s, a dynamic revival of this tradition has been taking place. The recent popularity of klezmer music has brought it far from its roots and into the sphere of mainstrean culture. If you haven't heard klezmer music yet, come for a new treat!

Joel Rubin is both a performer and scholar. He holds a PhD in ethnomusicology from City University-London for his pioneering work on klezmer music. He is currently a visiting scolar at Cornell and Syracuse universities. He studied clarinet with Richard Stolzman and Kalmen Opperman. He has directed several acclaimed klezmer ensembles, concertized in Europe, North America and Asia over the last 25 years, and records for Schott Wergo.

The DCC Concert series is made possible in part by public funds from the NYS Council on the Arts Decentralization program, administered by the Community Arts Partnership of Tompkins County. This is not the last concert this year: on December 12th at 3, Bells & Motley will give a holiday concert of music from the Renaissance. More information in the December News.

TASK FORCE UPDATE

The next meeting of the Comprehensive Plan Implementation Task Force is at 7:00 p.m. on Wednesday November 10. The open space protection strategies selected by the task force are being integrated into our laws and ordinances by Crystal Buck, county Planning Department professional and task force assistant. The task force met twice in October and is now focused on reviewing a rewritten version of the town's subdivision regulations. Crystal has inserted what is known as conservation subdivision procedures into our regulations in response to the guidance she has gotten from the task force. Those procedures amount to a new approach to subdivision outside the hamlets. The initial stage of subdivision would involve assessing the important natural features of a property and crafting lot creation in a way that minimizes negative effects on them. You can view the latest version of the proposed subdivision regulations on the town web site (http: //www.town.danby.ny.us/), or get a copy from Carol Sczepanski, Town Clerk and Task Force Secretary.

Once we finish with the subdivision regulations, the focus will shift to the zoning ordinance, and then to a completely new Conservation Flag Lot Ordinance. These three items (reworked sub-regs, changes to the zoning ordinance, and the flag lot ordinance) will comprise the legislative package to be proposed to the Town Board, probably in January. Formal consideration will involve Planning Board review and additional opportunity for public comment before passage, projected to be in March.

Although the task force is currently absorbed in developing and proposing open space protection strategies to adopt prior to the April expiration of the moratorium on subdivisions and rezoning, the stage is being set for the next phase of the task force's work, which is to look at how and where to focus growth. As mentioned last month, the town has applied for grant monies that would enable us to hire an consultant to lead us through creation of a strategic plan for developing both Danby and West Danby. We will need to accomplish much of the work proposed with or without the grant, since revising our laws to support continued on next page

development where we want it depends on resolving the question of how and where to grow the town. In the absence of the grant money, we will be forced to do the work ourselves, and in a somewhat scaled-back way. We should hear whether we succeeded in getting funded in January, which is when the task force will be freed up to proceed with that work in any event. Also to be done, and on a parallel track, is putting in place the structures and laws to enable the town to purchase development rights. A subcommittee of the task force, chaired by Ray Van de Bogart, has agreed on a framework for that effort and awaits the availability of staff support to move it forward. Much is happening. Why not be a part of it?

PERIODIC REPORT FROM FRANK PROTO

Our local bus system, TCAT, continues to log increased ridership in both Danby and Caroline. Due to the recent climb in gasoline prices and winter weather approaching we anticipate this increase to continue. Our board members have been strong supporters of the "one-zone weekend" fares, making it easier for mall-goers and riders working on weekends to get around. I'd appreciate your feedback on this, as we will be reviewing route strength as we do each year for budget consideration. The TCAT reorganization has been moving along in order to keep the timetable the state has directed. We're striving to make this transition with as few rider and employee impacts as possible, while achieving the change by January, 2005. Your comments and advice are welcomed.

The County's 2005 tentative budget has been released for public comment. It contains increases in capital spending for road and highway maintenance and improvements, developing plans for building a new and larger jail, and beginning the countywide communication system. The jail project will require another vote to actually go to construction, but the state corrections people wanted our commitment to proceed in order to extend the current variances. After reviewing the proposed communication tower project, I remain concerned over the extent of coverage to Danby in particular. As a result, I've asked for a meeting between our

town and county emergency people to understand what may be expected. The general revenue does contain a restoration of youth funding as many of you requested. We were able to reduce the rate by slightly over 4%, so barring any changes, the tax rate should be about 7.1%. It will be adjusted to reflect the sales tax credits for both Danby and Caroline, though Ithaca takes a cash contribution. To get a copy of the draft budget, please contact Jackie Thomas, Administrative Coordinator, at 274-5551. The budget hearing is set for 7 p.m., November 9 at the Town of Ithaca Hall.

The training the county is funding and sponsoring for those interested in establishing a rural small business and discussing micro-enterprise is going well. The sessions are full and well attended. If you have an interest in signing up call the Alternatives Federal Credit Union at 273-4611—they are organizing sessions.

The County Draft Comprehensive Plan is ready for public comment and will be available for review by 1 November. As with the budget, county executive proposal, jail project, and communications towers, I'd appreciate your feedback on this.

Our coffee sessions in Danby have been going well, and remain the Tuesday following Town Board meetings.

HISTORY NOTES

A Brief History of Buttermilk Creek and Jennings Pond

Buttermilk Creek

Buttermilk Creek has been an important water source for Danby since the late 1700's. Isaac and John Dumond built a sawmill on the creek in 1797 and Jacob and John Yaple built a gristmill on the creek in 1799. Both mills were adjacent to each other near Comfort Road. "Another mill, the Elm Tree Flour and Sawmill was organized in North Danby by Ellis, Johnson, Beers, and De Forrest in 1853 and became one of the most important manufacturing interests of the time. In 1856 ownership of the Elm Tree passed onto Thomas J. Phillips, who added steam power. The building was destroyed by fire in 1868 and the land remained vacant until 1875, when Frazier and Krum built a mill whose proprietor became W.R. Gunderman. In 1879 the mill had three runs of stone, ground about 50,000 bushels of custom work, and the sawmill turned out 100,000 feet of lumber a year." Buttermilk Creek is the source of water for the falls in Buttermilk State Park.

Jennings Pond

Lewis Beardsley originally owned the Jennings Pond property. In 1805 Mr. Beardsley sold his property, at the headwaters of Buttermilk Creek, to Joseph Judson who was then 24 years old. Judson had come to Danby in 1797, apprenticed to Dr. Lewis Beers. Young Judson damned the creek to form Judson's Pond. He built grist and sawmills and operated them using the water of the Buttermilk Creek. Arriving in 1802, at the same location, Benjamin Jennings "secured the water rights." The pond continued to be called "Judson's Pond" until 1895 when the Ithaca Water Company bought the water rights from Benjamin Jennings. It was their intentions to develop an additional watershed for the city of Ithaca's water supply. The Ithaca Water Company drained the pond for easy removal of logs and stumps and made improvements to the land surrounding the pond. "A Crane's Hill reporter in 1895 suggested that Jennings Pond be called Jennings Lake...an unsightly old pond, he declared, had been transformed into an respectable lake of 40 acres in area."

"In the early 1930's the Jennings family conveyed 10.75 acres to New York State. The parks commission built an earthen and flashboard dam, which they used to control the flow of water over Buttermilk Falls into the 751-acre Buttermilk State Park. In exchange, residents of Danby were allowed to use the pond for swimming, bass fishing, motorboats were prohibited."

In 1987 the dam on the Jennings Pond failed while being rebuilt by the state. "Engineers drained the inner pond in the fall but forgot to calculate the back pressure that it provided for a larger, semicircular earthen dam that held back the bigger pond. Under pressure from the spring runoff the dam collapsed, sending a wall of water '25 to 30 feet high' coursing through Danby, causing property damage." Today there is a new cement dam on Jennings Pond and swimming and fishing are still encouraged.
