LAURIE HART & PAUL MARCHAND CONCERT

Finish your Memorial Day weekend with traditional music from around the world. Laurie Hart of Ithaca, NY and Paul Marchand of Laurier Station, Quebec will present music from Quebec, Ireland, Scandinavia and France in the Danby Town Hall at 7pm on Monday, May 30th. The concert will feature a broad range of music from their newly released CD "Cobbler's Dream." The recording also features original watercolor art by Camille Doucet of Danby, NY.

Although they live in different countries and speak different languages, musically the duo understands each other perfectly. While collaborating on Danse ce Soir!—a recording and book of traditional tunes from Quebec—Hart and Marchand found that they had much more to express. They discovered a mutual interest in crossing boundaries while staying true to tradition. "Cobbler's Dream" is the result.

Paul Marchand is a master guitar player and singer, rhythmically propelling the beat with percussive foot tapping. His repertoire includes traditional songs of France and Quebec. Laurie is a classically trained violinist who has studied with master traditional fiddlers from around the world. In addition to Irish and Quebecoise fiddling, Laurie plays traditional Scandinavian music on the nyckelharpa and hardanger fiddle.

Appropriate for the entire family, this concert is free and open to everyone. It is part of the Danby Community Council concert series, and is supported by a grant from the NYS Council on the Arts and Community Arts Partnership of Tompkins County Decentralization Program.

TASK FORCE UPDATE

In April, the Comprehensive Plan Implementation Task Force scheduled the work before it. Hamlet Strategic Planning is now expected to begin in the fall, with the task being organized over the summer. Planning West Danby first is being considered as something of a pilot project.

Also over the summer, we hope to flesh out a proposal for implementing a non-regulatory open space protection initiative. The basics of this effort were worked out in one of the early Task Force committees, chaired by Ray Van de Bogart. It would establish a local Conservation Commission to identify key lands to protect and seek to buy the development rights to do so. That committee recommended a real estate transfer tax as a funding mechanism.

The real estate transfer tax has been successfully used at the eastern end of Long Island to protect land from development. Legislation pending in the State Legislature would enable municipalities across the state to use the same approach. The Task Force proposes to structure our local effort so that it is consistent with the requirements of the legislation, hoping that it passes. I will be proposing to the other municipalities in the county, via my role as chair of the Intermunicipal Planning Coalition, a committee of the Municipal Officials Association, that we collectively lobby for passage of this legislation.

Still to be completed, and the first priority of the task force, is "round 2" of regulatory changes aimed at open space protection. The April meeting dealt with a proposal to enable flag lots. Flag lots are lots behind frontage lots (the "pole" of the flag is the driveway). These can be used to conserve important open space resources primarily by giving the landowner greater flexibility in lot creation.

There are 2 parts to the proposal, and the task force endorsed them both. The first allows a flag lot to be substituted for a frontage lot, allowing some frontage to be spared. The second would allow a flag lot to be created in exchange for forfeiting the potential for some lots, reducing the total number of lots allowed. Essentially, it would require 15 acres to create a flag lot instead of 5 acres (this is separate from the flag lot by substitution for a frontage

lot just described). The lot created can be any size down to the minimum allowed.

The thought here is that a flag lot, because it can be accessed by driveway from an existing road, would be worth more to the landowner than the back lots of a parcel that would require construction of a road to access. This provision would be at the option of the landowner and would be an alternative to doing a complete subdivision plan.

Next up is a consideration of whether phasing could be used to encourage pre-planning of development. We would like to minimize the penalty for looking ahead to the potential future development of a parcel before lots are carved off of them.

Lastly, the group will consider a density bonus specifically targeted to the protection of agricultural land. This tool was previously rejected as being inconsistent with the overall objective of limiting development in the Low Density Zone, but the group agreed to reconsider in order to better address agricultural land protection.

Although ag lands are among the areas designated as desirable to include in the 60% conservation area for any given parcel, they would be included only after wetlands, steep slopes, and stream corridors. Also, they are usually the best drained and consequently the most easily developed areas. Shifting development to more difficult sites would involve additional expense. A density bonus, allowing more lots in these more difficult sites, would compensate for the increased cost and create an incentive to avoid the soils best suited to agriculture on any given parcel.

The task force will meet monthly until fall. The May meeting will be at 7 on Thursday, May 12 at Town Hall.

PUBLIC HEARING OPEN SPACE PROTECTION

The first round of changes to the Subdivision Regulations and Zoning Ordinance sent to the Town and Planning Boards for consideration have been adjusted in response to public, attorney, and Town and Planning Board comment and are now ready for formal public hearing. That hearing will be at 7:00 pm on Monday, May 9. The changes made to what the Task Force passed on have preserved the basic elements of the proposals while clarifying language and simplifying implementation to keep costs down for both the town and applicants. The full texts are now on the Web at http://www.town.danby.ny.us/ http://www.town.danby.ny.us/ and available at the Town Hall for review.

The changes are aimed at limiting development in the Low Density Zone. Parts of what are now the Medium Density Zone would be added to the existing Low Density Zone, as explained in the March Danby Area News. In the Low Density Zone, landowners would be entitled to one lot for every 200 feet of road frontage or one for every 5 acres, whichever is more. The minimum lot size would still be 2 acres, unless a smaller size were approved as a clustered subdivision. 60% of the total acreage would be designated conservation area, meaning essentially that it could not be used to put houses or their septic systems on. The conservation area can be included as parts of lots created, however, and used for lawns, gardens, woods, and agricultural land. The regulations would require that wetlands, steep slopes, and stream corridors be included in the conservation area, with unique natural areas and ag land desirable additions. Also desirable is configuring the conservation area into a minimum number of contiguous areas to maximize the value to wildlife and the potential for agricultural (including silvicultural) use.

Also a part of this package of changes is a procedural change aimed at earlier notification of the public when a subdivision is to be brought before the Planning Board. Public notice signs would be posted on the borders of the property adjoining roads prior to the Planning Board's first meeting with an applicant for subdivision and an opportunity for public comment provided at that first meeting. This is to ensure that ap-

plicants are aware of any neighborhood concerns before they formally draft their plans when it is easiest and least expensive to address them.

Unless something is raised at the public hearing that has not been previously considered and would require serious revision, the Town Board will probably vote on these proposals in May.

Deer are not picked up on weekends, but you may leave a message on the answering machine anytime.

HISTORY NOTES BY JOAN GRANT, DANBY TOWN HISTORIAN

Dr. Beers Part 2

At the age of 22, young Lewis Beers continued teaching. He was still living at home, and helped his family by paying for his room and board and clothing. He was having difficulty putting money aside for a future family and home, and decided that he needed to change professions in order to attain his goal. He frankly admitted that "with doubtful prospects before me, I conclude to try to obtain the profession of physic and surgery." In October of 1790, Lewis Beers gave up teaching school for a new career.

Stratford's Dr. Joshua Poor accepted Lewis as an apprentice. Dr. Poor agreed to accept partial payment of his training fees with the remaining to be paid when Lewis began his own practice. On November 1, 1790 he began his education. He wrote "My body was slender but my mind was strong and determined in whatever I engaged in; my mind was retentive, I could accomplish much in a short time. I was now impelled by that most active and powerful principle (a passion as some would choose to call it) of soul—Love."

The object of his affection was Miss Phebe Curtis, the daughter of a rich man. By December 9th of the same year the Curtis family insisted that Phebe curtail the courtship. However, she and Lewis continued to communicate by mail, she as Amanda and he as Aurelies, should their letters be intercepted.

In March of 1791 Lewis wrote, "I close my long and useful period of teaching school and turn my attention to physic and surgery under the care of Dr. Joshua Poor and took up my abode with him." He began reading medical literature in January, and continued to do so, plus he prepared medical compounds daily. Dr. Poor did not care for using his pestle and mortar, or for rolling pills, so most of this routine fell to the apprentice. Lewis was happy to do the work as it gave him a great deal of experience with the task that was an important part of his future duties.

By mid-April Dr. Poor was allowing Lewis to accompany him on sick calls, a privilege that Lewis really appreciated. He was well liked be patients, and by July Dr. Poor was hesitant to allow his apprentice to go along, as rumors suggested that once Lewis Beers became a doctor he'd settle nearby and take a portion of the good doctor's business.

Lewis continued his studies, finishing thirty-two volumes of medical literature by the beginning of August. When finished he said, "I felt prepared to present myself before some medical tribunal for an examination to know whether it would be proper for me to commence practice." Dr. Poor, feeling more fearful, refused to recommend his student and Lewis was forced to call upon a former apothecary instructor in New Haven to arrange for the four hour exam.

On August 22nd, 1791 Lewis emerged from the exam an honorary member of the medical society. Upon returning to Stratford, the new Dr. Beers presented his diploma to Dr. Poor, who read it over and returned it without comment. It was on that day that Dr Beers departed Dr. Poor's residence and returned home, feeling no animosity toward his mentor.
