Dan Duggan in Concert

Master hammer dulcimer player Dan Duggan is coming to the Danby Town Hall. The Sunday afternoon concert on October 5 at 3pm is sponsored by the Danby Community Council.

Based in New York's North Country, Dan has been touring the country for more than twenty years and has won the National Hammered Dulcimer Championship. He plays everything from traditional Irish and French Canadian tunes to 18th century harp pieces, along with Adirondack mountain music and tunes that filled American dance halls in the 19th century.

Dan also has a reputation or his original, innovative compositions. He played with Paul Simon on the You're the One album, won a Parents Choice award for a children's album, and has been heard in snippets on National Public Radio's *Morning Edition* and *All Things Considered*.

In his solo concerts, Dan mixes things up with songs and tunes. In addition to a hammered dulcimer of his own design, he often brings yang-quin, a Chinese dulcimer with its own sound. He is pretty good on guitar and banjo and may take advantage of the concert piano that lives in the Town Hall.

In concert, Dan creates an engaging mixture of music and storytelling. His deft enthusiasm makes traditional tunes sound fresh, while his soulful, original contemporary tunes honor the heritage of his musical roots.

This Danby concert is free for all ages. It is sponsored by the Danby Community Council as part of the concert series supported by a grant from the New York State Council on the Arts/Community Arts Partnership of Tompkins County Decentralization Program.

THE ICEBOX

The American Icebox dates back to the 1830s. It was the common appliance used to preserve, cool and store perishable foods before the advent of the electric refrigerator. The era of "ice harvesting" ran from the mid-19th century until the 1930s.

Most iceboxes were built of finished woods such as oak, pine, or ash. This was done for ease of construction, insulation and also its aesthetic value, and it wasn't until 1925 that steel and porcelain cabinets began to appear. The icebox had hollow walls lined with tin, zinc, galvanized metal, slate, porcelain or wood and insulated with various materials including cork, sawdust, seaweed, straw, charcoal and flax straw fiber.

A small drain with a rubber tube was built into the floor of the icebox and the melted ice--water--ran into a drain pan. The pan had to be emptied daily. Some finer models had internal holding thanks and a spigot to drain the ice water. Typical Victorian iceboxes were often fine pieces of oak furniture and the larger the icebox, the more well-to-do the home was.

The 1900 Sears & Roebuck and Montgomery Ward catalogues sold one door wooden iceboxes for between \$6.75 and \$10.25, depending on capacity.

Most municipally consumed ice was harvested in the winter from frozen lakes, ponds, and creeks. With the growth of cities, many of the sources of natural ice were contaminated by industrial pollution or sewer runoff. When early mechanical commercial refrigerators became available, around 1909, they were used in large industrial plants to produce ice for home delivery. The plants were able to produce clean, sanitary ice year-round and gradually replaced the ice harvesting industry.

The average icebox held a 25 or 50 pound block of ice

in a tray or compartment near the top of the icebox. Cold air circulated down and around the shelved storage

In the 1950s television show *The Honeymooners*, the set of the Kramden's apartment included icebox. The obsolete applicate emphasized their working class living conditions.

compartment(s) in the lower section. The most perishable foods (milk products and uncooked meats) were

stored at the bottom. A 25-pound block of ice cost about 15 cents in the early 1900s, and would last from one to two days during the hot summer months.

A sophisticated system developed around the delivery and payment process. Ice was purchased by the pound from a "frozen water man not unlike the milkman" and the price included delivery to the icebox. Coupons-

from 500- or 1000-pound books that sold for \$2.50 or \$5.00--were often used as payment to the iceman.

Customer also received a highly visible window card with numbers printed in various positions and directions. When placed in a window visible from the street, the upright numbers indicated the number of pounds of ice required. The iceman, in his horse-drawn wagon (or, later, gasoline truck) watched for the display cards. When he spotted a card he'd stop and chisel out the required amount

from a huge, pre-scored block of ice,

carry it to the residence with ice tongs and place the block in the top of the icebox.

On a hot summer day it wasn't unusual to find a caravan of children following behind the ice wagon, waiting for chips of ice to break off the massive block at stops.

In the 1920s, after the invention of the electric refrigerator, and with broadening electrification and safer refrigerants, the popularity of the icebox waned. The first refrigerator in widespread use was General Electric's *Monitor Top*.

Mass production of modern refrigerators started after World War II. By 1950, more than 80 percent of American farms and 90 percent of urban homes had one. Today, 99.5% of American homes have a refrigerator, making it the most common household appliance. Even so, the term "icebox" is still used colloquially to refer to the 'fridge.

If you or someone you know has an icebox you can

appreciate that they have a rare historic treasure and a fine piece of American furniture.

Supervisor's Update

This month's report to Danby residents has some catchup items and some new developments.

Our "Ride Share" effort has taken another step: we've signed up to participate in the County ride share program run by *AlterNetWays*. Individual Danby residents can sign up for the free program and contact other drivers and riders through the Tompkins County Rideshare web page. The Rideshare is open to anyone who wants to travel to or from Danby; it is up to us to see how many residents will reach out to other local travellers.

I am also working with the County to see if Gadabout can arrange pick-ups at the high school, to transport students to a central location where they can use Tioga Transit's 5pm bus back to Danby.

Our summer employment project to hire Danby youth was a great success. We're working to secure funds for next summer, to continue our trail loop around Jennings Pond.

New road signs, welcoming everyone to Danby, are in their final stages. Our thanks go to the Beautification Committee, who were able to secure the grant funding for these signs.

The Hamlet Planning group has been meeting. I encourage everyone who is interested to attend the upcoming public meetings and give input.

The Town budget—like yours—is taking a big hit this year thanks to rising energy costs. As petroleum costs rise, projections call for a 30 percent increase in the price of fuel oil for heating, increases for operating our trucks, and even increased cost for road maintenance.

With New York State in a financial crisis of unimaginable proportions, Danby is doing everything possible to keep its budget, and any changes to your taxes, in line with the cost of living index.

We are negotiating a new contract with the SPCA to provide animal control services. This will be a substantial cost to the Town.

Even so, one of my biggest concerns is in a different area: the current flurry of activity surrounding the sale of gas leases--for drilling--in the Danby area.

These leases represent big money and years of momentum by large, affluent corporations. There are leases being sold for \$100/acre and other leases for \$6,500/acre.

I am trying to sort out several issues and to get lots of question answered. For example, how likely is ground water contamination? The millions of gallons of water and chemicals used in hydrofracturing are toxic. Even if they can be completely removed, there are no known facilities to process this quantity of toxic chemicals. If the liquid is not successfully removed--or is spilled--and your well becomes contaminated, you cannot drink the water; possibly, you can't sell your house.

Tioga County is way ahead of Tompkins County in dealing with this issue. It is encouraging its residents to form a cooperative of sorts, to work as a collection of contiguous landowners who collectively negotiate leases. Check out its web site, [http://www.tiogagaslease.org/]. In addition, there is a massive class action suit from people who feel they were shafted on their leases; the group is trying to organize to renegotiate their leases.

Gas drilling was a high riority when I first mentioned it in the June Danby News, and it still is. I am doing my best to alert legislators to the issues and to differentiate fact from fiction. I urge you to learn what you can: attend forums that are offered in our community and nearby. Educate yourselves. I believe this is the single most formidable topic that will transform our Community.

There is evidence that unless we organize, like Tioga County, we have no control over the drilling process and its effect on our community and environment.

Town Observer

Town Board

A discussion about the increasing difficulty of getting around, especially for those who cannot drive (or can't afford to) led to Supervisor Ric Dietrich proposing a community ride board for the town's web site. It would be a place where people looking for rides could look for those offering them. The rest of the Board reacted positively. [see Ric's article for more info].

The Buttermilk Creek Aquifer Study is progressing. The latest manifestation was a Board resolution authorizing the supervisor to sign agreements with landowners allowing the drilling of test wells. Four or five new wells are planned in addition to the one drilled last year. At least one of those will be in the Danby Community Park. These wells will convey to the landowners upon completion of the study.

The Board passed a resolution authorizing the supervisor to write a letter of support for state legislation that would require the use of non-toxic materials in hydrofracturing. This is an issue in gas well development.

Board member Dan Klein, chair of the Comprehensive Plan Implementation Task Force brought up proposed changes to the draft *Right to Engage In Agricultural Activity* law. After discussion, Dan was asked to get feedback on the proposal from the County Planning Department and the Agriculture and Farmland Protection Board.

The Board authorized the Town Clerk to hire a dog enumerator. State law requires dogs to be counted every three years. The clerk pointed out that new, increased fees for dog licensing are in effect and will apply to unlicensed dogs discovered in the enumeration.

The Board set dates and times for its annual budget review. The review will precede the board meetings on October 6 and 13 and is the subject of an additional meeting on October 20, all at 6pm.

The reviews on the 6th and 13th will be interrupted for the regular Board meeting at 6:30pm and resume, if necessary, when the meeting ends.

Planning Board and Hamlet Planning

The steering committee met with the consultants on September 4 to lay groundwork for the hamlet planning workshops to be held October 24 in Danby and October 25 in West Danby. [See details in Sue Beeners article]. There will also be a public information meeting on October 2, at 7pm in the Town Hall, to give the public an opportunity to influence the process in advance of the planning workshops and to help inform all involved about how they will be conducted.

A major accomplishment was agreeing on rough boundaries for the study areas. [see the map accompanying Sue's article]. Examination of existing conditions and exploration of opportunities will focus on these areas.

Comprehensive Plan Implementation Task Force

Chair Dan Klein has discussed the Ag law with Monika Roth of Cornell Cooperative Extension and reported that she has not heard of any other New York town attempting to regulate CAFOs (confined animal feeding operations). Ronda Roaring agreed to search State law to see if such attempts have been made. The Danby law would simply state that CAFOs are not appropriate in Danby and the Danby zoning ordinance would be amended to disallow them. That provision would have limited applicability since the State Agriculture and Markets Law governs Agricultural districts, and much of Danby is within Ag districts.

Note that the federal definition of a CAFO includes direct discharge to a state waterway or a large number of animals. The Task Force knows of no Ag operations meeting that definition currently in Danby. The point of the CAFO language in a law whose main focus is to encourage and protect agriculture in Danby is simply to indicate that such operations are not what Danby wants.

The balance of the meeting addressed the larger question of development constraints and what part of these can and should be augmented by regulation. Frontage requirements, separation distances, and subtracting wetlands and steep slopes in calculating lot entitlements were some of the options identified. The entire issue will be revisited at the next meeting, currently scheduled for October 9, at 7pm in the Town Hall. \$\frac{1}{2}\$


