## FOCUS ON GAS DRILLING INFO

Public Information Session - August 22, 7pm

This issue of the Danby Area News contains many articles addressing natural gas extraction (hydrofracking) and the actions that the Town is taking to protect itself and its residents. # SUPERVISOR'S UPDATE

Even the occasional readers of my column in the Danby News know that I keep asking, "Please send, call, Email any and all questions you might have about the Town, what you like, what you see, suggestions, questions, and concerns." I thank all of you who have contacted me.

This month, I have a special request. Danby is embarking on some serious land use issues-and laws-that will have lasting effects on the Town and its residents.

Our Boards have frequently talked about and taken action on issues related to our Comprehensive Plan and the current Zoning Law (for example, our Storm Water Regulations and our Road Construction laws). These issues have been brought before the public through information forums and public hearings.

As you know, the Town has been working toward miti-

gating and controlling the effects of gas drilling operations, beginning over two years ago with our implementation of Road Laws. We are now considering a ban on certain types of industrial activity, including gas drilling.

The cost of writing these laws is a concern, but the expense of litigation to defend a ban is a bigger concern. The entire budget of the Town is a drop in the bucket compared to what a gas drilling company can easily afford to dedicate toward legal and court costs.

Many residents believe that gas drilling has a very real potential to dramatically change our quality of life, however you want to define it. The Town Board feels the pressure applied by residents on both sides of the issue. Our Comprehensive Plan, which has been crafted, revised, and reaffirmed during the last fifty years, reflects our residents' strong desire to preserve the rural character of the Town. This goal may be threatened by the recent turn of events.

## TOWN CLERK'S DESKTOP

#### "...We're Gonna Get Married..."

One of the happier aspects of my job is the issuance of marriage licenses, and the pool of people who can be married has just expanded.

On June 24, Governor Cuomo signed into law amendments to the NYS Domestic Relations law. They state that, "[a] marriage that is otherwise valid shall be valid regardless of whether the parties to the marriage are of the same or different sex." The law further states



that, "No application for a marriage license shall be denied on the ground that the parties are of the same, or of a different, sex."

There is no ambiguity regarding a Town Clerk's duties in the issuance of marriage licenses: the law states that a clerk must issue a license to applicants who meet the legal requirements set forth in the Domestic Relations Law. In addition, the State Comptroller's Office has

advised that a clerk must issue a certificate of marriage to a couple who have been issued a marriage license (by that clerk), once that license has been endorsed and executed by the person who solemnized that marriage.

Similarly, any government official who performs marriage ceremonies must do so to comply with this law.

July 25 was the first day for same sex couples to apply for a marriage license. In advance of that date, the NYS Department of Health updated the related forms and shipped them to Town Clerks. Special training was offered to help clear up any questions. For the most part, the process is no different than it was in the past.

A couple who intends to be married in New York State must apply—in person—for a marriage license and sign the license in the presence of the Clerk or the Clerk's Deputy. At least two forms of identification must be provided: a photo ID and a birth certificate. Once issued, a marriage license is valid for 60 days, beginning the day after it is issued. Although the marriage license is issued immediately, there is a 24-hour waiting period before the ceremony may take place. The waiting period is waived when a couple was previously married in a another state and simply want to renew their vows and receive a New York State marriage certificate.

The paperwork has changed a bit, primarily to comply with the directive that all language should be gender neutral. The headings above the two boxes where personal information is provided now *both* say, "Bride/ Groom/Spouse," and the person filling out the form may circle one of those titles. The personal information boxes allow participants to record gender, but this is optional information. Clerks may not ask for proof of gender. A marriage license may have any combination of grooms, brides, and spouses.

Any couple intending to wed in the State of New York may obtain a marriage license at the Danby Town Hall during our regular hours. I look forward to doing my small part, helping couples become formally and legally wedded. I particularly celebrate couples who may have waited decades for this moment.

#### Summer Intern...

If you visit the Danby Town Hall on Wednesdays, say hello to Raven, our summer intern. Raven is learning about activities in the Clerk's office but she is no stranger to Town Hall, having been involved with Danby's youth programming for several years. A quiet, yet dedicated worker, she has already helped with mailing dog license renewals and preparation for Danby Fun Day. She is currently weeding out duplicate material from our files. Raven will be with us through mid-August.

As a reminder, Summer hours for the Danby Town Clerk's office are Monday, Tuesday, Wednesday, and Friday, 10am-5pm. The office is closed Saturday mornings (in addition to Sundays and Thursdays) into August. And yes, the chocolate kiss bowl remains full.

#### Supervisor's Update, cont'd from front page—

The question of an actual ban has been carefully considered by the Town for a long time. It has not been a question of whether a ban was necessary to protect the health and welfare of the Town's residents, but of whether a ban would be legal and effective.

After careful consideration, and with input from several Attorneys, the Town has concluded that a ban on gas drilling could be effective, and is currently drafting legislation.

The mandated procedure to pass a local law requires several months, and a vote could occur as early as September. This vote will be well in advance of the earliest date when the NYS DEC could issue permits for gas drilling.

You may be aware that a petition is being circulated in support of a ban on gas drilling. Since the Town Board is already considering a ban, the petition can be seen as part of an effort to educate and alert residents: now is the time for discussion and for staying informed. We urge you to attend public hearings, or just to read the the minutes of hearings and meetings.

So, if someone comes to your door with a petition, give it serious thought; the Board will take the input of residents into consideration when the issue must be decided. If the wording of the petition is not an exact match for your opinion, ask the carrier to record your thoughts.

Information about how to assist the petition organizers by carrying it to as many of our residents as possible is presented in a separate article in the Danby News.

### DANBY FIRE DISTRICT ENERGY SAVING PROJECT Submitted by Patrick Caveney, Commissioner

An energy audit was conducted by Dana Ayers, a representative of the NYSEG/RG&E Small Business Energy Service Program, and both Danby and West Danby Fire Stations. This was initiated thru the Six Town Energy Coordinator, Ken Thompson of Town of Dryden.

The survey indicated that a significant energy savings could be achieved at Danby Station by updating lighting in the old truck bay. A district investment of \$398.85 will result in a significant savings with an estimated 3-year payback. NYSEG will contribute \$930.55 of the \$1329.40 total project cost by EnerPath.

Additional benefits will be improved lighting and lower lamp replacement costs, along with continued future availability of replacement lamps.

The Board of Fire Commissioners voted to implement this project at the July 12, 2011 meeting.

# Gas Drilling Task Force Update

The public is welcome to attend and to participate in the meetings of the Danby Gas Drilling Task Force. Its next meeting is on Wednesday, August 10, 7pm, in the Danby Town Hall.

### More comments to be prepared for the NYS Department of Environmental Conservation

The possibility of shale gas extraction in New York State is back on the front burner. The NYS DEC has released a proposed revised draft of the Supplemental Generic Environmental Impact Statement (SGEIS) on the Oil, Gas, and Solution Mining Regulatory Program. An additional section of the draft--discussing social and economic impacts--is scheduled to be released at the end of July. A 60-day comment period is expected to begin on August 1 and end on September 30.

The recently released document is over 1,000 pages long. Links to it, and other documents can be found on the Town's web site:

The web site also contains links to our comments to the previous, 2009 version of this document and other useful information.

We urge readers to learn more about this and related local initiatives and to use the opportunities available to make their opinions known.

The GDTF is working on written comments/responses to the SGEIS. We will assess whether, and how effectively, the new draft addresses our concerns. Anyone interested in helping with the review and comment, please contact us or come to the August 10 meeting.

### PUBLIC HEARINGS TO ADDRESS GAS DRILLING LEGISLATION Submitted by Pamela Goddard, Town Clerk

In the Hollywood version of legislative activity, the process of passing laws sometimes appears simple: a handsome politician stands up to propose action, the bad guys scowl, the yeas and nays are counted, and the newspapers publish the result. Nothing could be further from reality; when the Town of Danby enacts a law, it must follow strict rules of procedure mandated by the State of New York.

Once the legislation is formulated (in itself, a detailed and time-consuming process), neighboring Towns and bodies must be notified and given time to comment, official notices must be published, the public must be allowed an opportunity-a public hearing-to present written or verbal comments, the environmental significance of the legislation must be determined (this requires comments and a public hearing of its own) and voted upon, and then, finally, "the vote" can be counted.

The Town Board is currently considering two legislative items: an Amendment to the Town's Comprehensive Plan, and an Amendment to the Town's Zoning Ordinance.

As of this writing, the Town has scheduled Public Hearings for the Comprehensive Plan Amendment at 6:30pm and 6:45pm on Monday, September 12, 2011 (first, the environmental review hearing and then, the hearing on the Amendment itself) in the Danby Town Hall. It is anticipated that additional Public Hearings will be scheduled for the Zoning Ordinance Amendment at 7:30pm and 7:45pm on the same date.

#### The Comprehensive Plan Amendment

Danby's Comprehensive Plan was adopted in 2003 and hasn't been updated since then. The document guides the governance of the Town: it provides motivation and justification for the laws that the Town wants to adopt, but does not actually create any laws or rules.

The proposed Amendment supports efforts to preserve and protect the health and welfare of the Town and its citizens by providing for orderly and controlled growth. It introduces clear definitions of "industrial" activities, and explains why prohibiting and regulating high impact industrial and commercial uses and operations (including, but not limited to high volume hydraulic fracturing) will preserve and protect the rural, small town character of the Town and promote the public health and welfare.

#### Amendment to the Zoning Ordinance

This Amendment updates the existing Zoning Ordinance by clarifying the allowed uses of land in the Town and by distinguishing between "light" uses and "heavy impact" commercial and industrial operations. It defines terms describing industrial uses, such as "High Volume Hydraulic Fracturing" and prohibits natural gas and oil exploration and production, along with related activities, within the Town.

### MAPPING POTENTIAL DRILLING ACTIVITY IN DANBY

Darby Kiley, a Tompkins County Planner, and Art Pearce, a member of the Tompkins County Council of Governments Task Force on Gas Drilling, are going from Town to Town to discuss efforts to map the potential "buildout" of gas wells in Tompkins County.

They will bring Looking Down from Above: Mapping Potential Drilling Activity in Tompkins County to the Danby Town Hall at 7pm on Tuesday, August 23, hosted by the Danby Gas Drilling Task Force.

The TCCOG mapping presentation helps policy makers and citizens see where well pads might go in Tompkins County-and the Town of Danby-as permitted by current regulations. It illustrates the possible well placement in relation to houses, streams, steep slopes, and schools. It also provides information about how access roads and pipelines could affect the landscape.

The Tompkins County Council of Government's Mapping Working Group developed this set of photos and maps to help residents visualize how drilling might change the landscape of this county. It includes data from the NYS Department of Environmental Conservation's draft Supplemental Generic Environmental Impact Statement and information about the rate of drilling development in Pennsylvania. The group hopes to provide a quick tour of areas where drilling is already active and to illustrate potential local impacts of shale gas extraction. Ŝ
