Town Clerk's Desktop

The Town Board is busy considering local laws this summer and Fall. Two laws were passed during the summer: an Amendment to Subdivision Regulations and the long-awaited Groundwater Protection Law.

At the end of August, the Town Board began the process of enacting a Ballot Proposition for a Local Law changing the Highway Superintendent's from an elected to an appointed position by holding a public hear-

ing. In the near future, another public hearing is scheduled for September 19, to hear input about a local law allowing the Town to override the NYS tax cap for 2017, should it be necessary to continue services needed and expected by our residents.

In most cases, a simple majority of the board, three votes in favor out of the five voting members, is all that is need to pass a resolution enacting a Local Law. In some cases, a "supermajority" of at least four votes in favor are required. This was necessary in two recent matters;

review and potential approval for proposed changes for Planned Development Zone #10 on Gunderman Road (which would have required supermajority approval of a local law) and the Groundwater Protection Law.

Passing Local Laws: When a Majority Isn't Enough

There are at least two different situations when a simple majority (3 of 5) of the Town Board isn't enough to take action. In these situations, a *Supermajority* (4 of 5) is required.

The process for laws and proposals involving zoning changes includes a review of the proposed action by the Tompkins County Planning Department. Over the summer, the Planning Department's review of the Groundwater Protection Law, determined that there was a potential for the prohibition of pipeline facility installations to have negative inter-community impacts related to energy use in the County. As a result, passage of the Law without modification required a supermajority of the Board. In this case, the Board was in unanimous agreement—based on the recommendation of the Town Attorney and a professional geologist—to pass the law as written, so a supermajority was achieved.

In the case of proposed changes to PDZ #10, a supermajority was triggered when neighboring property owners objected to the change (specifically, the trigger was the percentage of properties physically adjacent to PDZ #10's property line). In this case, after almost two years of consideration, the proposal did not reach a final vote; instead, faced with the need for a supermajority, the applicant withdrew his request. Given the withdrawal, the Board voted unanimously to terminate the process, but without prejudice to future applications for changes.

Hunting Licenses

The sale of DEC sporting licenses keeps Sue and I busy in the Clerk's office during September. *Doe Management Permit* (DMP) sales began early this year, on August 1 and continue through the end of the work day on Saturday October 1. We will be open that day, as a service to Danby hunters.

Each year, we encourage Danby hunters to make donations to the New York State Venison Donation Coalition. The Venison Donation coalition is a non-profit organization that coordinates efforts of hunters, deer processors, food banks, and other individuals to add locally sourced food to New York State food banks. Ground venison is distributed through food pantries, soup kitchens, and senior living centers. One deer can provide up to 160 servings of highly nutritious ground venison to those in need. It's easy to support this effort, even if you butcher your own venison. Simply tell the clerk to click the donation link and the small fee of \$1 will be added to the license fee. Donations can also be accepted through the secure website, or send a check payable to: Venison Donation Coalition, Inc., 415 West Morris Street, Bath, NY 14810. In order to be as accessible as possible, the Town Clerk's office is open 10am-5pm Monday, Tuesday, Wednesday, and Friday. Saturday hours return after Labor Day weekend, 10am-Noon. As always, we are closed on Sundays and Thursdays. And yes, there's still chocolate in the bowl on the counter.

COUNTY LEGISLATURE UPDATE

The NYS Commission of Correction recently informed Tompkins County that they are eliminating the variances that have enabled us to put more prisoners in our jail than state law normally allows. This will force us to do one of two things: build a bigger jail or reduce the number of people in our jail.

No one wants to build a bigger jail. Social justice advocates and libertarians have made their voices heard in this county, telling us that we should not be investing more money in prison infrastructure. Taxpayers have told us that they want the budget kept in check, and a larger jail would be a big-ticket item.

We have invested resources in trying to reduce the number of people in our jail. We have in place good alternatives to incarceration programs that would take a whole other column to write about. However, we are also up against large societal forces over which we have no control, and which seem to be working in the opposite direction.

NY State law requires a minimum number of square feet per prisoner in their cells. I think everyone would agree that such a law makes sense. I hope that people on all sides of this issue will keep that in mind as we, the residents of Tompkins County, have this meaningful debate about what to do about our jail.

I worked this summer for the NY State Department of Corrections, teaching horticulture in a state prison. In between watering petunias and pulling out dandelions, I talked a lot with inmates about their lives, their experiences in prison, and also about the specific issue of expansion of our County jail. Their views on the issue were varied, just as they are among my friends, neighbors, family, and colleagues. And also like anyone else who has spent time thinking about and looking into this issue, they were of the belief that there is no easy answer.

Tompkins County is undertaking several studies to help us get a handle on what our options are. We are hoping NY State will give us a little more time to evaluate these options before they retract our variance for the jail. I can't predict at this point how this will all play out.

The easy thing for me to say is that I don't want an expanded jail, I don't want to increase taxes to build it, and I don't want to obligate taxpayers to the long-term cost of operating it. The hard thing for me to say is how to accomplish that. One thing that I hope everyone will keep in mind as we all debate this issue is that criminal justice, social justice, and public safety are complex issues, and that it doesn't serve us well to enter this debate with rigid beliefs that are not subject to evolving as we learn more.

WEST DANBY WATER DISTRICT UPDATE

Due to the drought we experienced in June and July, I didn't schedule our August system flushing. As I write

this, we are getting much needed rain so I plan to flush our hydrants during the week of September 12 to 16. Weather permitting, I will flush on Monday September 12 starting about 9am.

We are now considering changing billing software companies from BAS to Williamson. BAS's services hasn't worked for us as we



do not have the internet capabilities to use its technical support.

SUPERVISOR'S UPDATE

During August, two major projects that have been on our agenda for years—changes to PDZ #10 on Gunderman Road and our Groundwater Protection Laws—have finally been put to bed.

The applicant who requested permission for additional uses in PDZ #10 has withdrawn his proposal and our Groundwater Law is now apart of our Zoning.

We are in the final stages of our long-term electrical project. Its goal is to offset all our municipal electric usage with a large-scale array of solar panels located on the grounds of our Highway Department. The project requires permitting by several regulatory authorities and usage agreement from our fire, water, and highway departments. In the long run, we hope to realize savings of the Town's tax dollars.

The Highway Department is still busy with repairs to flood damage from a year ago, piggybacked onto its annual work to keep our infrastructure in top order. Our Town Planner, CJ Reynolds, is preparing grant applications to help Highway seek funding for remediation of Brown Road and a major culvert crossing for Michigan Hollow Road.

Zoning issues continue to be on our agenda, everything from law suits challenging our right to issue building permits to infractions of our unsafe buildings law, both are in court as I write.

The Broadband and Time-Warner situations are still up in the air. If any of you have given thought to approaching either Time Warner or Clarity Connect about your service, please let me know how that is going. My conversations with Clarity and a meeting with the Time Warner negotiating team (set for late August) still give me a optimistic outlook that some progress is being made, although it's frustrating in its process.

Expansion of South Hill Recreation Trail also drags on, with challenges to its right of way. The Town of Caroline, which would host a larger section of the Trail than Danby, is stepping up to the plate to hire Guy Krogh, our mutual town lawyer, to unravel a complicated legal history. The next meeting on that issue will have happened after this goes to press. I am encouraged that this project will prevail, as I believe there is progress.

Bids for sidewalk repair around Town Hall—including a handicapped access ramp that meets Code—are being sent out, so we'll have a good idea of the costs. This is vital since budget time is upon us, and we are in the process of gathering data from each of our cost centers.

As is becoming more common among other taxing jurisdictions, the Town Board initiated the process to override the NYS Tax Cap Law, in case that becomes necessary for a balanced budget in 2017. A public hearing is set for September 19.

During August, the Town Board initiated the process of changing the Highway Superintendent's position from an elected to an appointed one. By the time you read this, a Public Hearing will have taken place and the Board may have voted to put this choice on the November ballot, so voters can make the final decision.

A petition for a speed limit reduction on Lieb Road was received in early July and was forwarded to the County (and State) in late August. The Town Board also initiated a similar request for lower Gunderman Road, Fisher Settlement Road, Bald Hill Road, and Station Road. The NYS Department of Transportation will make the final determination.

HIGHWAY SUPERINTENDENT: ELECTED OR APPOINTED?

In a late breaking development, Danby's Town Board voted on August 15 to begin the process of raising the question-again-of whether the Highway Superintendent's position should be changed from an elected one to an appointed one.

Like the last time the question was raised, six years ago in 2010, the process began with a Public Hearing. That hearing was scheduled for August 30, 2016, and the Board may have voted at that time to make the Superintendent's job an appointed one, which automatically places the question on the November 8 ballot.

In the end, Danby's voters make the final decision.

The Process

The process begins when the Town Board passes a local law changing the Superintendent's status. Like all local laws, any such vote must be preceded by a Pub-

REPORT OF FIRE DISTRICT ENGINEERING STUDY

Back in April 2016, I wrote about a planned engineering study of the Danby Fire District's apparatus and equipment. This is what that study found.

The report lauds us in at least one respect: "From an overall perspective the Danby Fire District maintains an adequate number of pieces of apparatus and equipment to adequately protect the community." It also cautions us that, "The cleanliness, care, and attention that is paid to the fleet cannot stop the effects of time and corrosion on this collection of older apparatus. The significant capital investment to acquire, equip, and maintain these specialized emergency vehicles dictates that aggressive steps be taken to maximize the service lives of the vehicles in the fleet today."

In short, the study found the need for an increased level of maintenance on three of our most expensive trucks. Both Engine 401 and Engine 1401 have undercarriage corrosion and the Tanker 1421 has both corrosion and bad tires. Minor maintenance is required on Emergency Medical 443.

One truck, Tanker 421, is already being replaced and the study agreed it was time to do so. The replacement is under construction at this writing and is expected to join our fleet in late 2016. This is funded by a bond issue approved by the voters.

Further, the report notes that not only do we have old apparatus, we have several units that are past any reasonable expectation of their useful lives, need new tires to meet State mandates, and are overweight.

lic Hearing, but only ten days notice of the hearing is required. Unlike most local laws, though, this change requires a *mandatory referendum*, giving local residents the chance to confirm the change...or to reverse it. This vote would take place as part of the General Election on November 8.

Pro and Con

An article in the August, 2010 *Danby News* summarized the arguments in favor of and against the change:

The reasoning behind switching this position from elected to appointed is that it is not a political position. It is a technical position that requires the best person for the job.

The other four trucks in our fleet should be replaced. In two cases, the design has been superseded by current and anticipated needs, and the costs of keeping any of them exceed replacement costs.

Four problems were specifically called out:

- 1 Items stored or carried and not in proper mounting brackets or in locked compartments in accordance with standards. [suggestions to fix]
- 2 Operating personnel must climb to the top of the unit to retrieve tools or equipment. [safety enhancements suggested]
- 3 Several vehicles require new tires. Mandates on systems and components should be carefully followed. [specifics provided]
- 4 Vehicles are overweight; the excess weight cannot be removed and keep the truck functional. The vehicles need to be retired.

So, the Fire Commissioners have directed the Fire Chiefs to begin the required maintenance and replace the necessary tires. We have a reserve of maintenance funds that should cover most of this work, but depleting these reserves implies a need to restore the balances over the next few years.

We have also begun the process of specifying brush truck replacements and the retirement of the Heavy Rescue truck in West Danby. The heavy rescue equipment has already been transferred to the new engine, 1401, and an emergency Rescue Vehicle is being acquired using funds from a reserve account. Brush truck replacements are more expensive and yet time critical and discussions are underway.

To conclude, the study has been most useful in helping us understand our current challenges, developing our budgeting, and developing our long run plan.

Currently, the only people eligible for this position are adult residents of Danby (and that is the only requirement!). No one currently working for the Danby Highway Department is eligible to run for Highway Superintendent...because they are not Danby residents.

On the other hand, Danby residents may want to keep the current system so that they have more direct control of who their public servants are. Keeping this position as elected rather than appointed could provide more checks and balances in government.

If you read this issue of the *Danby News* on or before Tuesday, August 30, you still have time to run down to the Public Hearing in Town Hall at 7pm.


