THE THING ON THE CARPET

A FRIEND OF MINE CALLED and said he had this "thing" on his living room carpet. He wasn't sure that it was, but he thought it might be some kind of bug that had come in on his shoe. Would I come over and look at it? So I did.

Mind you, I don't do this for everyone. He helps me a lot and even helped me after I took my toilet off and replaced the gaskets and couldn't get it back on again. So, there was this brown thing on his carpet. "It's a firefly larva!" He was happy to know that and put it outside.

Firefly larvae "hibernate" over the winter. I found one asleep on a log on my wood pile this spring. They wake in April as soon as the weather starts to warm up. They wander around looking for a place to pupate (that is, turn into a winged firefly). They go into friable soil or under leaves and bark on the ground and sometimes between pieces of bark on the trees. So watch out for them when you're digging in your garden.

The fireflies emerge in June to mate and lay eggs that spend the rest of the summer and early fall growing in long grass and other low vegetation. You can see the larva on YouTube by searching for "ever seen firefly larvae" (include the quotes). Watch the whole thing so you see the head come out.

I saw my first firefly of the year on May 13, crawling on my deck. If you had looked at it, you might have said, "Wow, that insect looks a lot like a firefly, but it can't be as it's out during the day and not luminescing." Well, it just so happens that we do have a diurnal, non-luminescing firefly in the

Tax Policy To Preserve Danby's Quality of Life

When we look out our windows or when we walk or drive around Danby, we see why we live here. Greenery in Summer and clean snow in winter are both easy on the eye. That's Danby's rural character. Danby even has a policy that encourages preservation of open space and rural character!

All the residents of Danby appreciate and benefit from the natural beauty and rural character provided by open space, yet the cost of providing this benefit falls disproportionately on the owners of the large, open properties.

The problem is that NYS assessment guidelines have changed in recent years, shifting the long-accepted balance between the value of housing and the value of the land the houses sit on. Rapidly rising property tax on land puts ever-increasing pressure on landowners to subdivide into smaller parcels and to develop. This, in turn, threatens preservation of open space in our Town.

Some owners have seen the assessed value of an acre rise from \$1,000 (in recent memory) to \$2,500 or more. This change doesn't do much to the tax on Danby's average \$175,000 house-and-a-few-acres, but make that 10 or 20 acres, or even 100 or 200 acres, and pretty soon you're talking real money (and crushing taxes).

Conservation Easements protect open space but are not accompanied by significant relief from property taxes (Federal: none, State: limited). Many landowners are hesitant to restrict the use and value of their land without compensation. Even landowners who want to preserve open space may be uncomfortable with a permanent conservation easement.

DURING COVID - 19

WE STILL FIND OURSELVES in the midst of the COVID crisis but there is some positive news for some. If all goes as planed, by the time you are reading this article, portions of the NYS PAUSE will have been lifted for construction and industry.

This will not mean business as usual for contractors, large or small. There will be requirements in place set forth by New York State that will have to be met in order to work on job sites, such as a return-to-work plan posted at the job site outlining mask use and social distancing practices as well as cleaning of tools and other infection control measures to help stem the spread of the virus and cause further outbreaks. As the Town Code Enforcement Officer I will be checking for these postings and requiring compliance as part of my inspection process.

With the summer weather approaching some of the more popular projects that happen early in the season are decks, storage buildings and swimming pools. I would just like to remind the residents of the Town that these all require a building permit (storage buildings with more than 144 sq. ft. floor area, even pre-built shed transported to your site and installed).

Building permit applications can be found on the Town web site [townofdanbyny]. If you request one by Email (below) I will send you a building permit application packet. Any projects being done by the homeowner at their own home or being done by a one person contractor crew will not need a back-to-work plan.

Another piece of information that some people may not be aware of: once a building permit has been issued it is required to be displayed in a location that is viewable from the public way.

SUPERVISOR'S UPDATE

As I write this, this part of New York State is entering phase one of the great reopening. By the time you read this, we may be moving into phase two-provided phase one goes well. It will, if we are careful to work and play safely. Social distancing needs to be a normal part of our interaction, coupled with mask wearing and staying home if we don't feel well. Testing is now much more available, so recognizing hotspots and dealing with them is easier. Construction is among the business activities that are cleared to resume—with safe operating procedures in place. Our Code Official, Steve Cortright, has more on that in his article this month.

If you need masks, there is now enough of a supply that the state has made some available to distribute to those who need them. Ours can be found in the food "pods" or cabinets (which also have free food for those in need). Those pods are on Maple Avenue in West Danby, at the Danby Community Church, and at the Gathery. There is one at the Coddington Road Community Center as well, serving part of Danby as well as Caroline, in which it is located.

At last account, participation in the national census was just over 50 percent in NY. Being counted is important for a number of reasons. For one, it determines our representation in Congress. Also, federal funding is often linked to population, so the closer we are to including everyone in the count, the better. If you haven't yet participated and can access the web, visit [my2020census.gov]. If you do not have web access or don't get to it, the next round will be by mail. If you still don't respond, there will be actual enumerators reaching out. Each step is more time consuming and expensive than the preceding one. Give our public servants a break—get yourself counted sooner than later!

Melis (see Youth Flyer) is being very creative in devising on-line programming for our youth to participate in, making up in part for the inability to do in-person activity. Group gatherings of any sort will be one of the last things to resume. If there are no spikes in infections that could be as soon as late summer. Until a vaccine becomes widely available (or most of us have contracted the infection and gotten over it—or not), the risk associated with crowds will remain. The Jennings Pond summer swimming program is a casualty of that reality, at least for this year.

Videoconference meetings are the order of the day for some time to come, and they have their advantages. No commute to get to them, for one. A good group of people have joined in for the grand planning effort, with upwards of 35 engaged so far. Email exchanges between meetings have explored some subjects in depth, giving us a sense of what it is we all like and seek to preserve and enhance. As Jason mentions in his article, one initiative has already been endorsed by the Planning Group and made its way to the Town Board for consideration. That proposal, if it is adopted locally (and it first needs state enabling legislation for that to happen) would give landowners a break on their property taxes in exchange for a commitment not to develop their land. The magnitude of the tax relief would be in proportion to the length of the commitment. This proposal was prompted by the concern around rising assessments on undeveloped land. For large landowners especially, the tax burden is making it hard to hang on. Since there is very little chance of legislation of any kind happening in Albany in this highly unusual year, we have ample time to carefully consider what any proposal we want to ask the state to let us do should look like.

Don't forget that the ticks didn't take a break and our protective measures for COVID-19 don't do anything to deter them. So, be on the watch for them as we spend more time basking in the warmth. It has been a long winter!

COUNTY LEGISLATURE UPDATE

As I feel necessary to say each month, the deadline for the Danby News is more than two weeks before its publication date. Since many aspects of the current situation change quickly, this is not the place to get up-to-the-minute updates. The best place for that is the Tompkins County Health Department website. For those without internet access, call 211.

The County Legislature held its first budget meeting of 2020. Normally we start the budget process in late April for the following year. However, this budget meeting was entirely about how we are going to deal with the big hole in the 2020 budget. The size of the budget gap is very difficult to predict because we don't know yet if the college students will be returning in the Fall, we don't know if there will be another federal stimulus bill aimed at state and local governments, and because this years' NY State budget contained a provision for the Governor to change the amount of money allocated to local government and school districts throughout the year.

We are taking a number of steps to cut down on expenses. We have furloughed approximately 90 employees. We are leaving about 30 vacant positions unfilled. We are considering early retirement to certain employees. We are cutting back on some capital projects. We are looking at ways to save in health insurance costs.

All I can say about the 2020 budget is to stay tuned.

Due to the large amount of uncertainty, we have delayed beginning the 2021 budget process until August.

On a completely different topic, the County legislature is considering adjusting the length of terms legislators serve, at least temporarily. It is not our choice to take up this topic now, but the election calendar requires it.

The basic issue is that the census data will not be ready in time for redistricting for the 2021 election, when all the Tompkins County Legislature seats will be on the ballot. The decision we have to make is do we A) do nothing, leave the terms at four years as they are now, with the result being that the districts will not match census data until the election of 2025, or B) adjust the length of the term in some way to shorten the amount of time that the districts are out of alignment with census data.

If we decide to adjust the length of the term in some way, we must make that decision by early July.

FIRE DISTRICT UPDATE

JUST SIGNED ON TO WRITE news articles for the Danby Fire District, on behalf of the fire commissioners. My first question: what, exactly is a fire commissioner?

Fortunately, I had to look no further than the Danby News to find the answer. Former commissioner Ed Kokkelenberg wrote that fire commissioners are responsible for overseeing fire department expenditures, writing grants, and preparing the budget.

Think about it: a fire department has a complex infrastructure, including a building, trucks, and equipment that must be maintained, and purchases, large and small, to make to ensure our safety. The fire commissioners, who, like fire department members, serve on a volunteer basis, ensure that all this gets done at minimal taxpayer expense.

Fire commissioners are elected, and each serves a five-year term. Elections are held every December, so there is always a mixture of experienced and newly elected commissioners.

Fire Department COVID Response

I also want to address a timely subject: how the fire department has adapted to the COVID-19 pandemic.

According to DVFC ("uphill") Fire Chief John Gaden, his department has increased its use of personal protective equipment (PPE). This is particularly true for EMTs, who now wear not only gloves but also face shields and gowns.

It's a good thing the department has adopted these precautionary measures, as it has already responded to several calls, including a car accident, involving potentially COVID-positive persons. For now, the department has enough PPE, but supplies are limited and may be hard to get in coming months.

What should you do if you think you might have COVID? Gaden says to call 2-1-1 for information, and head up to the Ithaca Mall to get tested. "Don't hesitate, don't wait. Go and get tested as soon as you can." In the meantime, you might want to take extra precautions. \$

To preserve open space, the Town needs to address this inequity. An incentive is needed, to encourage landowners not to turn to development to make their properties tax-affordable. Without rebalancing the tax burden, the Town risks having its open space sold, either to ongoing development or to the wealthy few who can afford the taxes. The result would be a great change to the rural character of our Town.

The Tax Working Committee of Danby's Planning Group thinks it has found a way to reconcile Danby's emphasis on rural character with the unfortunate consequences of Property Tax policy set by New York State.

The Committee investigated NY State Tax Law and found other NY Towns with similar concerns. These Towns turned to the NY State Legislature, which approved tax relief for land preservation by incorporating special exceptions into NY's Real Property Tax Law. These "Section 491" exceptions provide for the creation of tax exemptions—50 to 90 percent—tied to Conservation Easements.

With Section 491 relief from the State Legislature, the Assessment Department can rebalance the tax burden away from larger parcels that enter into conservation easements. This will encourage open space preservation. The Planning Group endorsed this recommendation and the Town Board is considering action.


Now, the hot-button question: how much does this cost? For the Town (and the County, School Districts, and others, if they choose) it's revenue-neutral. They don't need to make changes to their tax levy.

Based on data provided by the Assessment Department, the 50 largest taxable properties in Danby—18 percent of its land—are assessed for about 3.5 percent of Danby's total taxable value. The other 1900-odd parcels are another 20 percent of the total; the remaining 75+ percent of the value is in housing.

Even if all 50 properties were covered by easements (impossible, since some are commercial) and were awarded full exemptions (unlikely without perpetual easements) and that change happened overnight (more likely, over a period of years), that 3.5 percent would be spread among Danby's 1,900-odd other parcels. In this worst-case example, the average \$175,000 property, which currently gives Danby about \$1,150 annually, would see a roughly \$40 increase.

More realistically, the increase would be smaller. The committee and the Planning Group agree that this is a small cost compared to the value of preserving the open space that provides Danby's residents with highly-valued rural character.

MAP OF THE MONTH CLUB

This month's map is a *choropleth* heat map, a visualization of the density of assessed price per acre in Danby. The coloring represents "dollars per acre', that is, *both* the price and the density of properties.

The lowest price density is light gray, with increasing value thru dark gray into white. For example, White Hawk EcoVillage's cooperative structure (modestly-priced, but tiny properties, very close together), displays as a "circle" of high density of dollars per acre. Buttermilk and Beardsley have a similar coloring; a lot less modestly priced but farther apart.

Price density tends to follow roads while the undeveloped space between roads is less dense. The lowest density tends to be open space because the high value of larger parcels is spread across many acres.

PLANNING GROUP UPDATE

As REPORTED IN PREVIOUS DANBY NEWS, the town has embarked on a wide-ranging planning effort. In January, the Town Board authorized the formation of the Danby Planning Group, an advisory body made up of representatives from the Town Board, Planning Board, Board of Zoning Appeals, the Conservation Advisory Council, augmented by any and all interested in Danby's future. New members are always welcome!

The Planning Group has formed four working groups, each focusing on a different subject matter. These are:

Conservation Working Group—focusing on what areas of the town need protection from further development. This group is also discussing fundamental questions including what natural habitats are most important and how "rural character" is defined.

Hamlets Working Group—focusing on how to strengthen and revitalize the hamlets of Danby and West Danby and what areas of the hamlets can accommodate new development. This group is also discussing how to improve the hamlets and what would make them even more desirable places to live.

Tax Policy Working Group—focusing on how to provide tax relief for owners of large parcels of open space or wild land. These large undeveloped parcels are enjoyed


