SUPERVISOR'S UPDATE

HAVE BEEN THINKING a lot about the Black Lives Matter movement and its underlying challenge to not just policing but to structural racism in this country. This evening (6/17), the Danby Town Board voted to support the placing of a BLM banner on Danby's Town Hall and declared Juneteenth (June 19) a local holiday honoring the end of slavery. These are easy symbolic actions, but they reflect an underlying commitment to fair and just law making and enforcement.

Laws are not always intended to promote the general welfare. Sometimes they advantage one group over another. You can be sure that when laws are used to, "keep people in their place," the ones doing the legislating are not in that place. Almost all laws constrain our freedom to act. Most would be unnecessary were we to act with consideration and respect for others.

Even when laws are enacted with all good intent, they can be instruments of injustice when unevenly applied. Drug laws apply to everyone, but their uneven prosecution filled our jails with minority offenders. The proposal to defund the police is a response to the failure to inculcate fairness in our policing. Body cameras and policies on use of force cannot assure fairness or compassion. Laws and their enforcement are not the only or necessarily best way to deal with problematic behavior. Sometimes (usually, in fact) working things out with your neighbor is better, and intervention by professionals trained to deescalate confrontations are far more likely to produce satisfactory resolutions than the use of police. I am proud of the long-standing commitment of both legislators and law enforcement in this county to alternatives to incarceration. Treatment and prevention have been demonstrated to work--cost-effectively.

I don't think that we have a big problem with racial antagonism or hatred here in Danby or Tompkins County. The root of injustice is more subtle than that. It lies more in indifference and a groupthink that depends on seeing others as different in order to support a sense of belonging. It isn't actively malevolent, but it leads to an exclusivity that is fundamentally at odds with equality of opportunity and a just and fair society. When we work to include instead of exclude, to embrace diversity as a strength and not a liability, to work for the common good and not our personal advantage, then we all benefit. HAMLET GRANT UPDATE

IN LATE 2019, the Town received a Tompkins County Municipal Housing Affordability Grant to advance Town and County goals of hamlet revitalization and affordable housing. This \$10,000 grant is for consulting services to research practical engineering and regulatory options for hamlet-scale development using onsite and potentially offsite waste water treatment. In tandem with the consultant'a research on water and waste water options, the Town Planner will be drafting revised zoning regulations for the hamlet areas to remove obstacles to traditional hamlet-scale development.

The request for qualifications (RFQ) was posted June 17 and is being advertised broadly through the New York State Contract Reporter and other outlets. This RFQ is posted on the Town'a Planning and Zoning web page, [townofdanbyny.org/planning]. Proposals are due to the Town of Danby no later than 6pm, July 10, 2020. COUNTY LEGISLATURE UPDATE

As I WRITE THIS in mid-June, I am again faced with the problems of the time delay between now and when you will be reading this in early July.

As I write, we just entered phase 3 of reopening. Hopefully by the time you read this, we will have entered phase 4. As I write, the County has seen only one new case of Covid-19 in the last week. I hope that positive trend is continuing.

In mid-June, the County began a program to provide rent-relief for about 150 renters in the County for 3 months (this is in addition to a program to help an additional 50 homes in the City of Ithaca). This money is from a federal Community Development Block Grant the County received that was intended to be used to repair homes of low-income residents. We received permission to repurpose that money to provide rent-relief for low-income households who have experienced economic hardship due to the corona virus. Hopefully some Danby renters who needed that money got it.

I just want to be clear that in this rent-relief program, landlords receive 100 percent of what is owed them. There are other rent-relief proposals out there where rent would be forgiven but landlords would not be reimbursed. I am not in favor of that kind of program.

If a residential property does not pay its taxes for 3 years, or if a commercial property does not pay its taxes for one year, those properties are foreclosed upon by the County. As of this writing, there is only one property in Danby that is subject to foreclosure this year. I hope that by the time this is read, that property owner has found a way to settle their debt. It may be cold comfort to those who ultimately cannot come up with the money to pay their taxes, but the County does everything in its power to avoid foreclosure.

The budget outlook for the County government continues to look bleak, and I will be writing in more detail as the specifics get fleshed out. We just had a presentation from Tompkins Cortland Community College about their budget situation, and it too is bleak. The only likely scenario that could change all this in the near-term would be a federal assistance bill aimed at local government. And that too is something that I hope has been resolved in a positive way by the time you read this.

As I write this, early voting is underway. As you read this, the election is over, and for the first time voters in NY were allowed to vote "no-excuse" absentee, or better

W.D. WATER DISTRICT UPDATE



said, vote-by-mail. Many states do this for every election. NY instituted this, so far, just for this one election. NY State made a number of election reforms last year. Here's hoping that vote-by-mail gets added to that list soon.

As I write this, NY State just became the first state in the nation to pass police reform. The national and local conversation is welcome.

Let me say a little bit about police reform in terms of County government. Tompkins County has an elected Sheriff. The Sheriff gets to make policy for the department, the County legislature does not. I support our Sheriff, and I like his position on the current situation and discussion about race and policing. However, I have supported in the past, and would support again, changing the Sheriff's position from elected to appointed. I know this is a controversial topic. I think it is better to pick a Sheriff based on qualifications rather than on political party and popularity. I think we will see municipalities that make meaningful changes to policing policies are able to do so because they have appointed chiefs, not elected chiefs.

FIRE DISTRICT UPDATE

ATTENDED MY FIRST Fire District meeting on June 9 and learned just how complicated running a fire district consisting of two departments is. For example, hose must be inspected every year and personal protective equipment must be replaced every ten years. Not only does it take time to make purchases and set up inspections, it costs money. Most of the money comes from the 2 percent of property taxes that goes to the fire district, which cover 100 percent of the normal operating expenses of the Fire District. The rest comes from grants, which are used to purchase equipment and meet other occasional needs that would otherwise require using additional tax revenue, dipping into limited reserves, or bonding.

In 2019, thanks to New York State Assembly Woman Barbara Lifton, the district received \$125,000 from the State and Municipal Facility Program for the purchase a new rapid attack brush truck for West Danby. In 2017, the district received a \$123,000 FEMA Assistance to Firefighters Grant for the purchase of 20 new self-contained breathing apparatus (SCBA) units, which are easier to refill and have more safety features than the 20-year old packs they replace.

The Triad Foundation of Tompkins Country has provided consistent and generous support, most recently with grants for the purchase of UTVs for working in difficult terrain. This spring, the foundation also provided a small grant for a thermal imaging camera that allows firefighters to locate victims in dense smoke, determine how hot the walls are, and find lost or injured people in natural areas.

The two Fire Departments have also held chicken BBQs, pancake breakfasts, and the ever-popular Danby Fun Day to raise money for department needs.

The Danby Fire District is very grateful to Barbara Lifton, the Triad Foundation and all the other grantors whose support has made such a difference in insuring the safety of our community and first responders. We are also grateful to all those in the community who support our volunteer firefighters through tax dollars and by attending department events.

CAC UPDATE

THE CONSERVATION ADVISORY COUNCIL held its monthly meeting via Zoom on June 9. The main items on the agenda were the Planning Group's tax abatement proposal, management plans for two properties owned by the Town and a proposed logging ordinance. We also discussed possible designs for a sign that might be displayed on Town of Danby easement properties.

Last month's Danby News had articles describing the proposal from the Planning Group that the Town Board should ask the New York State Legislature to add Danby to the list of Towns allowed to offer partial property tax exemptions tied to Conservation Easements. The Town Board asked the CAC to provide input on this proposal, and we had a long and thoughtful discussion. The CAC was enthusiastic about the proposal, including the fact that easements would not have to be granted in perpetuity, but could be for shorter terms, with lower tax exemptions. However, for a number of reasons, there was unanimous agreement to recommend that the Legislature not include an additional short term (5-15 year) easement category or a proposed additional tax exemption for landowners allowing public access to their properties.

The Town of Danby owns two pieces of land: a wooded area in Deputron Hollow and the West Danby Water Board property on Sylvan Lane. In both cases, the recommendation has been for passive management of the properties. A subcommittee has now been established to complete formal management plans for these two properties.

As a result of the disastrous logging on a private property in Deputron Hollow a few years ago, the CAC discussed introducing a logging ordinance, so that we can keep track of logging activities in the Town and encourage landowners to use best management practices when logging. A subcommittee was tasked with coming up with a proposal for a logging ordinance, but this was never finalized. The subcommittee has now been reactivated and will be reporting back to the CAC in the next month or two.

Our next meeting will be held (via Zoom) at 7pm on Tuesday, July 14.

THE MAN, THE HAT, & THE MOUNTAIN



RICK DOBSON AND HIS ROAD FRONT PROPERTY along NYS Rt.96B have been well known to Danby residents for many years. Dressed in his signature cowboy hat, he could be found at fire station pancake breakfasts, at Town Hall meetings, and other events. Rick passed away on June 17, at his home next to his salvage yard.

According to Gay Huddle, during Rick's last days, Danby Fire Chief John Gaden put together a small "parade" for Rick Dobson, where Rick could see Fire Department friends and share in a salute. Rick was an intensely proud veteran.

Shane Spencer got to know Rick during his position as Road Patrol Deputy with the Tompkins County Sheriff's office; Rick was an active volunteer with the Danby Fire and Rescue team. He remembers Rick's determination and care on several occasions. Spencer also recalls many conversations with Dobson about the mountain in the center of his property.

Rick had many visions for Astreeian Mountain (named after his granddaughter), including it being a community spot where people could, "get away from it all," and enjoy the view. Dobson had expressed a desire to be cremated and have his remains in a memorial spot at the top of his beloved Mountain.



Rick had many friends in Danby. Dobson considered himself a protector and booster of Danby. He often expressed the hope that a business could be found to develop on his property. *Dobson Enterprises* was often used as a staging area for the Danby Fun Day parade, and Rick took pleasure from tossing small toys to children from his parade float.

That combination of civic engagement and playfulness was unique to Rick Dobson. He will be missed. Our sympathy goes out to all the people who looked after him during his "sunset years" and during his illness.

left-hand side for further instructions. The cutoff for requests will be Tuesday. The requested items will be in a plastic bag, labelled with the patron's name and placed on top of the outdoor book drop located at the Town Hall entrance.

Any library items that are currently signed out may be returned to the outdoor book drop and, moving forward, all returns are to be placed in the book drop. These items will remain untouched for 72 hours, per guidelines from TCPL. At that time, they will be wiped down and placed back into circulation. The library volunteers will comply with all safety procedures set forth by the Town Hall.



DID YOU KNOW?

HAVE A GREEN CATERPILLAR eating one of my plants. So, I got out this amazing book called Caterpillars of Easte6rn North America, by David L. Wagner, and started looking. But I got overwhelmed by the nearly 1,000 photos of caterpillars, many of them green.

I had some idea of what it was, but it was still small, and I couldn't see all the markings yet. So I went online and searched for "green caterpillar." That was just as bad. Most of the photos were people asking, "What caterpillar is this?" But I found an interesting web site, [owlcation.com] (click on "Green Caterpillar Identification" at the left of the page).

I narrowed my caterpillar down to the copper underwing, went back and looked at it. Seemed to be right. Then I read in my book, "The caterpillar perches on the underside of a leaf, often with the anterior part of the body raised." Yep, that's it. Then I read that it "eats many woody plants, including apple...." And this one was on a young apple tree. Success.

Keep looking for and learning those green caterpillars.
