One well has been drilled on the Town Highway Property. The site at the Danby Community Park has not been drilled and has been deferred until spring. There will be new sites.

Town of Caroline Planning Board Request

Susan Barr who is Chairperson of the Town of Caroline Planning Board sent a letter to the Danby Planning Board requesting that surrounding towns join a consortium. The consortium is to explore the future of the South Hill recreation way through Caroline to the county line.
